The company strives to reach zero flaring level as they believe natural gas has a potential to become a cleaner source of energy.

The company is closely following the latest technologies and innovations, and is monitoring the enhanced oil recovery mechanisms, research, and investment techniques. ADNOC

has also keenly helped in developing Abu Dhabi's hydrocarbon resources by enhancing the procedure of safe and sustainable recovery from the reservoirs. It has also initiated to evaluate the opportunities of carbon dioxide flooding for Enhanced Oil Recovering, besides sequestering it in target reservoirs.
